For many years we have been successfully cooperating with the UN within the framework of our activities in many countries.

We maintain international projects in the field of human rights protection and we are acting under direct agreements with the state law enforcement structures.

Main objective of International Human Rights Defense Committee (CIPDH) is the protection of inalienable human rights, support of state, international, public, religious and other organizations in struggle against the illegal actions which are violating human rights.

We are hoping a lot for further cooperation with you and we are obliged to clarify the situation with our employee Mr. KALOSTROVIC MILAN (citizen of Montenegro. Address: Petrovac. Brezine BB. Date of Birth: 21.06.1976).

1. Mr. Kalostrovic Milan was appointed as the Counsellor of CIPDH Organization in Montenegro. We confirm that we have issued a service documents named "CIPDH diplomatic passport" to Mr. Kalostrovic Milan , diplomatic credential and special vehicle plates UN787CD.

These documents are considered as internal documents of the organisation and cannot serve as a substitute for a national passport.

Special vehicle plates UN787CD can be used only for official CIPDH missions in Montenegro and have to be accepted by the local police of Montenegro. All state documents for Nissan Pathfinder

If the verification of Mr. Kalostrovic Milan is completed and if there is no crime of law in his actions, we are asking to return his service documents issued by our organization. We will also attach the copy of Mr. Kalostrovic Milan national passport.

The work in CIPDH is incompatible with illegal activities and we are willing and ready to provide all necessary information.
